 - On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or
 - He / She is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointees have been declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential

requirements as prescribed in the Union Territory of Ladakh Handicraft (Subordinate) Service Recruitment Rules, 2022.

4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.

It is further ordered that;

1. The services of the above candidate appointed as post Senior Craft Instructor (Group 'C', Technical), in the Department of Industries & Commerce of the Administration of Union Territory of Ladakh for further deployment.
2. The appointees shall report to the office of Director Industries & Commerce UT Ladakh for joining within a period of one (01) month, from the date of issuance of this order, failing which his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.


