Whereas, pursuant to the recommendations of the Staff Selection Commission, Mr. Fida Hussain S/O Shri. Ghulam R/O Chulichan, Kargil was provisionally selected as Senior Craft Instructor in the Department of Industries & Commerce (Handicraft) UT Ladakh in the pay level-6 of pay matrix (₹ 35400-112400) under UR category.

Whereas, Industries & Commerce Department UT Ladakh vide Memorandum No. A/585/2025-I&C SECTION/101-105 dated 24.04.2025 issued an offer of appointment to the candidate selected provisionally for the post of Senior Craft Instructor with the directions to submit the acceptance undertaking within 30 days from the issuance of memorandum.

Whereas, Director Industries & Commerce UT Ladakh has intimated that provisionally selected candidate has not submitted acceptance undertaking for the post of Senior Craft Instructor as he has accepted the offer for the post of Technical Assistant.

Whereas, in terms of instructions contained at para (15) in the Memorandum issued by the office of Administrative Secretary, Industries & Commerce Department UT Ladakh, the candidates who fail to submit the undertaking within a period of 30 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Now therefore, in view of the above, the offer of appointment issued in favor of Mr. Fida Hussain S/O Shri. Ghulam R/O Chulichan, Kargil to the post of **Senior Craft Instructor, Group 'C', Technical, in the Department of Industries & Commerce (Handicraft) of the Administration of Union Territory of Ladakh** shall be deemed to have been cancelled w.e.f. 20.05.2025.


