NOTIFICATION Leh, 27th of June, 2025

S.O. 75.— Whereas, the Administration of Union territory of Ladakh, vide Order No. 343-LA(GAD) of 2023 dated 19.10.2023, constituted a One Member Commission under the chairmanship of Hon'ble Justice Bansi Lal Bhat, Former Judge of the High Court of J&K and Ladakh; to identify areas / villages / hamlets adjoining the Actual Line of Control (ALC) for the purpose of reservation under the J&K Reservation Act, 2004 (as amended by the Union territory of Ladakh Reservation (Amendment) Regulation, 2025 (No. 1 of 2025)) in its application to the UT of Ladakh;

And whereas, the One Member Commission submitted the Final Report of the Identified Areas Adjoining Actual Line of Control (ALC) to the Administration of Union territory of Ladakh in the month of December, 2024;

And whereas, *vide* Order No. 15-LA(GAD) of 2025, dated 06.01.2025, an Internal Committee was constituted to examine the final report submitted by the One-Member Commission. The Internal Committee, after perusing the Report has recommended acceptance of the findings related to the areas adjoining the ALC which have been identified by the One Member Commission, forming the Schedule to the Report;

And whereas, the Administration of the Union territory of Ladakh has decided to accept the recommendation of the One Member Commission, inasmuch as the areas / villages / hamlets forming part of areas adjoining Actual Line of Control (ALC) in the Union territory of Ladakh.

Now, therefore, in exercise of the powers conferred by *clause* (*c*) of section 2 of the Jammu and Kashmir Reservation Act, 2004 (*as amended by the Union territory of Ladakh Reservation (Amendment) Regulation, 2025 (No. 1 of 2025)*), in its application to the Union territory of Ladakh; the Administrator (Lt. Governor) of the Union territory of Ladakh is hereby

pleased to declare the following areas / villages / hamlets as the Areas Adjoining Actual Line of Control (ALC) in the Union territory of Ladakh for the purpose of reservation under the Jammu and Kashmir Reservation Act, 2004 (as amended by the Union territory of Ladakh Reservation (Amendment) Regulation, 2025 (No. 1 of 2025)), in its application to the Union territory of Ladakh, namely:—

NOTIFICATION Ladakh, the 27th of June, 2025.

S.O. 77. — In exercise of the powers conferred by section 23 of the Jammu and Kashmir Reservation Act, 2004 (as amended by the Union territory of Ladakh Reservation (Amendment) Regulation, 2025 (No.1 of 2025)), in its application to the Union territory of Ladakh, and all other enabling provisions in this behalf, the Administrator of Union territory of Ladakh, hereby makes the following rules further to amend the Union territory of Ladakh Reservation Rules, 2005 (hereinafter referred to as the "said Rules"), namely, —

- **1.** Short title and Commencement,— (1) These rules may be called the Union territory of Ladakh Reservation (Amendment) Rules, 2025.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- **2.** Construction of reference of certain expressions by certain other expressions, Throughout the said Rules,
 - (a) the expression and words "/ International border" or the words "or International border", wherever they occur, shall be omitted;
 - (b) for the words "Social Welfare Department", wherever they occur, the words "Social and Tribal Welfare Department" shall be substituted; and
 - (c) for the words "Physically Challenged persons", wherever they occur, the words "persons with benchmark disabilities" shall be substituted.
- **3.** Amendment to Rule 2, In rule 2 of the said Rules,
 - (a) clause (iii) shall be substituted, as follows, namely: —
 "(iii) "Areas adjoining the Actual Line of Control (ALC)" mean the areas declared as such, by the Administration of Union territory of Ladakh from time to time;":
 - (b) clause (iiia) shall be omitted;
 - (c) clause (v) shall be omitted;
 - (d) after clause (xi), the following clause shall be inserted, namely: —
 "(xia) "person with benchmark disability" means a person as defined under clause (r) of section 2 of the Rights of Persons with Disabilities Act, 2016 (Act No. 49 of 2016)."; and
 - (e) clause (xv) shall be omitted.

- **4. Amendment to Rule 4,** In the said Rules, rule 4 shall be substituted by the following rule, namely:
 - **"4. Reservation in Direct Recruitment.** Except as otherwise provided in these rules, available vacancies shall be reserved for direct recruitment in each service, cadre, class and grade in favour of domiciles of the Union territory of Ladakh belonging to any of the below mentioned categories which shall, as nearly as possible, constitute the percentage of available vacancies shown against each: —

(a)	Scheduled Castes	01%
(b)	Scheduled Tribes	80%
(c)	Socially and Educationally Backward Classes, namely, Residents of areas adjoining the Actual Line of Control (ALC) in the Union territory of Ladakh.	04%
(d)	Economically Weaker Sections (EWSs)	10%

Explanation (A): — The reservation for the categories (a) to (c) mentioned in the table above shall be for those holding *domicile certificate* as provided at Sl. No. 1 and Sl. No. 2 in column - II in the Table under rule 4 of the Ladakh Civil Services Decentralization and Recruitment – Grant of Domicile Certificate (Procedure) Rules, 2025.

Horizontal Reservation

(e)	Ex-servicemen	06%
(f)	Persons with benchmark disabilities	04%

Explanation (B): — The horizontal reservation to the extent of 06% of the available vacancies shall be provided to the Ex-servicemen against Group 'C' posts only where the maximum number of the applicable pay level does not exceed Level - 5 of the Pay Matrix.

Explanation (C):— For purposes of *category (e)* and *(f)*, for Group 'C' posts, the horizontal reservation means the reservations which would cut across the vertical reservation (what is called inter-locking reservation) and the person selected against the persons with benchmark disabilities quota will have to be placed in the appropriate category, namely, if he/she belongs to the scheduled tribe category, he/she will be placed in that quota by making the necessary adjustment and similarly, if he/ she belongs to the unreserved category, he/she will be placed in that category.

Explanation (**D**): — For the purposes of *category* (*f*), reservations in recruitment shall be available for persons with benchmark disabilities for services and posts specified under Section 34 of the Rights of Persons with Disabilities Act, 2016 (*Act No. 49 of 2016*), to the extent specified therein, namely:

(a)	Blindness or low vision;	1%
(b)	Deaf and hard of hearing:	1%

(c)	Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy, spinal deformity and spinal injury without any associated neurological / limb dysfunction;	1%
(d)	Autism, intellectual disability, specific learning disability and mental illness;	1%
(e)	Multiple disabilities from amongst persons under <i>clause</i> (a) to (d) , including deaf blindness in the posts identified for each disability.

- **5. Amendment to Rule 5,** In the said Rules, rule 5 shall be substituted by the following rule, namely:
 - **"5. Roster for direct recruitment.** (1) With a view to giving effect to the reservation herein before provided in this part, the appointing authority shall, in respect of each service, cadre, class and grade in the services and posts under the Union territory of Ladakh, maintain a roster of 100 vacancies in the form given hereinafter: —

Note: The expression "Actual Line of Control" used in the table above, means the residents of areas adjoining the Actual Line of Control (ALC) in the Union territory of Ladakh, declared as such, by the Administration of Union territory of Ladakh from time to time.

The roster shall be maintained as a running account from year to year and will start at the commencement of a year at the point following the point which was utilized at the end of the previous year:

Provided that, where the last point utilized in the preceding year was a reserved point and was treated as unreserved for want of a suitable candidate from the reserved category, the first point to be started as aforesaid shall be the reserved point:

Provided further that, where, on any occasion of selection in any year, a reserved vacancy is treated as unreserved for want of a suitable candidate from the reserved category, the succeeding unreserved vacancy shall on the next occasion of selection in that year be treated as reserved.

- The roster register shall be maintained as per the details given in Annexure (3) *E*. ".
- 6. **Amendment to Rule 6,**— In the said Rules, rule 6 shall be substituted by the following rule, namely: —
 - "6. Custody and Maintenance of roster. responsibility (1) The for custody, maintenance and updating the roster shall be as under:
 - for the Union territory Cadre posts, the roster shall be maintained by the requisitioning authority, which shall ordinarily be the Administrative Department in the Administration:

Provided that, the Administrative Department concerned may, with prior concurrence of the Social and Tribal Welfare Department, authorize the Head of the Department concerned to maintain roster;

(b) for District Cadre posts, the roster shall be maintained by the requisitioning authority, which shall ordinarily be the Administrative Department in the Administration and a copy thereof shall be kept with the District Officer concerned at the District level. It shall be the duty of the Administrative Department to ensure that both the roster and its copy are verified and validated by the Concerned District Officer, at least once in each year whether or not a recruitment process takes place during this period:

Provided that, the Administrative Department concerned may, with prior concurrence of the Social and Tribal Welfare Department, authorize the Head of the Department concerned to maintain roster; and

- (c) for services to which direct recruitment takes place through Combined Competitive Examination, the General Administration Department shall maintain a separate roster for each service and the Cadre Controlling Authority of each such service shall also maintain and update the roster for the service. Such Departments shall furnish to the General Administration Department break-up of the vacancies to be filled by direct recruitment at a selection.
- (2) While the roster shall be maintained in accordance with rule 5, it shall be the responsibility of every selection agency to send a return as per the Annexure F to the Social Welfare Department on the day it notifies the recommendation for appointment:
- (3) It shall be the duty of the Liaison Officer of the department as provided in the sub-rule (3) of rule 26 to maintain the roster for services for which the department is the cadre controlling authority and non-maintenance of roster by the Liaison Officer shall be considered as "misconduct" as provided in sub-rule (1) of rule 3 of Central Civil Services (Conduct) Rules, 1964 and for such misconduct he shall be liable for any of the penalties as provided under *clause* (i) to (iv) of rule 11 Central Civil Services (Classification, Control and Appeals) Rules, 1965.".
- **7. Amendment to Rule 7,** In the said Rules, rule 7 shall be substituted by the following rule, namely:
 - **"7. Preparation of the Select List.—** (1) The selection authority shall draw up, in order of merit, a consolidated list of all the eligible candidates irrespective of class or category to which they belong. The list shall show classification of the candidates category wise.
 - (2) The selection authority shall then prepare from out of the first list, a second list containing the names of candidates equal in number to the total number of un-reserved vacancies to be filled up, arranging them in order of merit, commencing with the first name in the first list, hereinafter called second list. If there are no reserved vacancies, then the second list shall constitute the select list subject only to the provisions of subrule (6) and (7).
 - (3) If there are reserved vacancies as well, the selection authority shall next prepare from out of the portion of the first list remaining after excluding the portion corresponding to the second list, a third list containing the names separately of as many candidates, from each of the categories, as the number of vacancies respectively reserved for them arranging the candidates from each category in order of their *inter se* merit:

Provided that, the third list shall be prepared beginning with the filling up of EWS vacancies:

Provided further that, if an EWS vacancies remain unfilled, due to non-availability of a suitable EWS candidate in the first list, then the un-filled vacancies shall be treated as unreserved and be filled first, before filling the other reserved category vacancies, in the same manner as provided in sub-rule (2) and be added to second list:

Provided further that, if the said third list added to the said second list shall in such case constitute the select list, subject only to the provisions of sub-rule (6) and sub-rule (7):

Provided further that, the placement of selected candidates in the select list shall be in order of merit, to ensure that their *inter se* seniority is based strictly on merit.

- (4) If in the case of any of the aforesaid categories (except the category of EWS), the number of candidates belonging to such category in the third list falls short of the number of vacancies reserved for it, the remaining reserved vacancies for such category shall be treated as backlog and the procedure as provided under section 5 of the reservation Act shall be followed.
- (5) If, there are reserved vacancies alone against which selection is to be made, the selection authority shall invite applications from the members belonging only to that class for whom the said vacancies are meant. It shall then draw up a list of the candidates in order of merit, out of which shall be prepared another list containing names of the candidates equal in number to the number of the reserved vacancies arranged in order of merit commencing from the first name in the initial list mentioned above. The list so prepared shall constitute the select list for these reserved vacancies subject only to the provisions of sub-rule (6) and sub-rule (7).
- (6) Notwithstanding anything to the contrary contained in sub-rules (1) to (5), the selection authority shall provide horizontal reservation to the extent specified under rule 4 to the candidates falling under the categories ex-servicemen and persons with benchmark disabilities while preparing the roster under the said sub-rules.
- (7) The list as finally settled by conforming to sub-rule (1) to (5) above shall constitute the list of candidates finally selected for appointment to any particular service, cadre, class, category or grade, as the case maybe, for which such selection is made at a time.
- (8) For purposes of services to which Combined Competitive Examination is conducted, the reserved category candidates if selected against open merit vacancies may also be considered for allotment of services allocable to their respective category as per their inter-se-merit / own preference and the resultant left over vacancies in the services in open merit shall be allotted to those reserved category candidates only, as per merit-cum-preference, against whose vacancies the reserved category candidates qualifying in the open merit are considered:

Provided that persons with benchmark disabilities shall be considered for selection in the services and against the posts identified for their respective categories.".
