## **NOTIFICATION**

The Administration of Union territory of Ladakh, in collaborating with IIT Delhi, IIT Bombay and IIT Kanpur (jointly referred to as IITs), for creating opportunities for Engineering Graduates of the Union territory of Ladakh, to pursue Postgraduate(PG) level Programme at the three IITs through sponsored M. Tech. Programme (incl PhD) by the Union territory of Ladakh, so as to create a pool of eligible resource persons for the proposed Ladakh Institute of Technology, in the larger public interest.

As per this notification, all candidates who apply for the Sponsored M. Tech Programme (incl PhD) must execute a Compulsory Service Bond to serve in the Union territory of Ladakh, for a prescribed period of 03 (three) years immediately after the completion of the course, if the UT Administration requires so. The bond has to be executed and submitted in original in the office of the Department of Higher Education, Union territory of Ladakh.

It is accordingly informed to all the aspirants for the aforementioned Sponsored M. Tech Course (incl PhD) that the following Clauses regarding execution of the Bond before admission to IITs by whatever name called, shall come into force from the academic session 2022-23 and onwards as under:

## PG Service Bond for M. Tech (incl PhD):

**Clause - 1.** It is hereby stipulated that the candidates of the Union territory of Ladakh, availing the benefit of sponsored M. Tech Course (incl PhD) in any IIT Institutions mentioned above, shall have to execute a Service Bond in favour of the Administration of Union territory of Ladakh, stating that he/she shall serve under the Administration of Union territory of Ladakh, if the UT Administration requires so, for a period of 03 (three) years immediately after successful completion of such M. Tech Degree Course (incl PhD),

**Clause – 2.** In the event of failure to serve for the stipulated period under the Administration of Union territory of Ladakh under Clause 1, he/she shall pay **Rs.25** Lakh to the Administration of Union territory of Ladakh.

Clause- 3. In the event of failure of the candidate to complete the course obtained under sponsored MTech course (incl PhD) offered by the Union territory of Ladakh, in any of the IIT Institutions mentioned above, he/she will have to pay the total cost incurred by the Administration on the course for the candidate (up to a max limit of Rs.14 Lakh) to the Administration of Union territory of Ladakh.

Clause-4. The Candidate is bound to formally inform the Administration of the Union territory of Ladakh, regarding his/her successful completion of the Course immediately after the completion of the sponsored M. Tech course (incl PhD, wherever applicable). The Service Bond obligation will not apply to a candidate, if his / her appointment (on contractual or regular basis) is not made by the Administration of Union territory of Ladakh, within a period of 6 Months from the date of communication to the Administration regarding his / her successful completion of the Course & his / her eligibility for service.

**Clause - 5.** Any violation of the terms and conditions of the Bond shall invite stern disciplinary action as per the rules and regulation as are applicable. The details of such candidates will be reported to the Engineering Council of India for appropriate action.

**Clause - 6.** Any outstanding amount payable to the Administration of Union territory of Ladakh, from the applicant shall be recovered from him/her as an arrears of land revenue.

AND WHEREAS after successful completion of the course of study, the bounden shall serve any of Government project/site for a period of 3 (Three) Years anywhere in the Union territory of Ladakh and also subject to the terms and conditions hereinafter appearing; if the UT Administration requires so.

and the bounden and the sureties have agreed to the same.

NOW, the condition of the above written obligation is that in the event the Bounden fails to serve the Administration of Union territory of Ladakh for period of Three Years, if the UT Administration requires so, the Bounden and Sureties shall forthwith pay to the Administration of Union territory of Ladakh on demand the total amount of Rs. 25 lakhs/- (Rupees Twenty-Five Lakh Only) towards failure to fulfil the obligation. The bond is legally binding on the bounden and the sureties, and upon the payment of such sum, the above written obligation shall be void and of no effect otherwise this shall remain in full force and effect.

And if the Bounden discontinues the study or fails to complete the Sponsored M. Tech Course (incl Ph.D) to which he/she was selected, the Bounden and Sureties shall forthwith pay to the Administration of Union territory of Ladakh on demand, the amount as per the cost incurred by the Administration on the course for the candidate (up to a max limit of Rs. 14 Lakh) towards failure to fulfil the obligation.

The Candidate is bound to formally inform the Administration of the Union Territory of Ladakh in writing regarding his/her successful completion of the sponsored M. Tech (including PhD) course. The Service Bond obligation will not apply to a candidate, if his/her appointment is on a contractual or regular basis, is not made by the Administration of Union territory Of Ladakh, within a period of six (06) months from the date of such formal communication to the Administration regarding his/her successful completion of the Course & his/her eligibility for the service.

PROVIDED further that the Bounden and the Sureties do hereby agree that if the Bounden discontinues the study or after completion of the Sponsored M. Tech Course (incl PhD) of study to which he/she was selected, fails to serve the Administration of Union territory of Ladakh for a period of 3 (Three) Years, if the UT Administration requires so, it may be construed as violation of the bond and the fact reported to the concerned authority for suitable action.

PROVIDED further that the bounden and the sureties do hereby agree that all sums found due to the Administration of Union territory of Ladakh under or by virtue of this bond, shall be recovered jointly and severally from them and their properties movable and immovable, as if such dues were arrears of land revenue under the provisions of Revenue Recovery Act for the time being in force, or in such other manner as the Administration of Union territory of Ladakh may deem fit.

Provided further that it is not necessary for the Administration of Union territory of Ladakh to sue the bond holder before taking action on the surety, under this bond and the liabilities of the sureties is co-extensive with that of the Bounden and shall not be affected by the Administration of Union territory of Ladakh giving time or any other indigence to the bounden or by the Administration of Union territory of Ladakh varying of the terms and conditions herein contained.

In case the Administration does not immediately require the services of the Candidate after completion of the course, it shall not be construed as a waiver of the bond conditions. The Candidate shall remain bound under this Bond and may be called to serve any time within a reasonable period, as determined by the Administration.
