Subject: Implementation of New Direct Benefit Transfer (DBT), related protocols in PFMS-reg.

Reference is invited to the communication F. No. D-11011/24/2016-DBT (Vol.II) dated: 27.06.2025 received from the Cabinet Secretariat/DBT Mission, Government of India, regarding the reduction of payment failures in Direct Benefit Transfer (DBT). It has been informed that, Public Financial Management System (PFMS) has recently deployed two new protocols: 'Partial Acceptance' and 'Sharing of De-seeded Adhaar' to reduce payment failures in DBT.

OFFICE MEMORANDUM

Subject: Implementation of New DBT related protocols in PFMS - reg.

The undersigned is directed to reiterate that reduction of payment failures in DBT is a top priority and towards this end Public Financial Management System (PFMS) has recently deployed two new protocols: 'Partial Acceptance' and 'Sharing of De-seeded Aadhaar'.

- 2. Further, PFMS has informed that:
- (a) 'Partial Acceptance Protocol' has saved around 6.63 crore DBT Transactions (16% of total records initiated across 18 external systems) from being rejected;
- (b) 'Sharing of De-seeded Aadhaar Protocol', has reduced the credit rejection due to the reason 'Aadhaar number de-seeded from NPCI mapper' from 62.9% of total DBT failures in 2023-24 to 28.9% in 2024-25.
- 3. However, vide letter No. AC-18011/2/2025-PFMS/E-18161/949-950 dated 21st May, 2025 (copy enclosed), Controller General of Accounts has informed that the aforesaid protocols have not yet been implemented by all the stakeholders.
- 4. In view of their efficiency and effectiveness, all DBT implementing Ministries / Departments and States / UTs are hereby requested to ensure implementation of these protocols at the earliest.

Subject: Implementation of new DBT protocols.

Sir,

Direct Benefit Transfer (DBT) payments are facilitated through the IT-based platform of the Public Financial Management System (PFMS). PFMS is continuously involved in closely monitoring payments made under various DBT schemes, with a focus on improving system efficiency and ensuring better service delivery for Ministries/ Departments and beneficiaries.

- 2. In this regard, PFMS has deployed two new protocols namely, (i) Partial Acceptance Payment Protocol and (ii) sharing of De-seeded Aadhaar information with the systems integrated with PFMS for DBT payments (External System).
- 3. The advantages of these protocols are as follows:
- i. Partial acceptance protocol: Previously, if a single record in a payment file was incorrect, the entire file would be rejected, leading to unnecessary delays in processing valid payments. Under new protocol, correct records in the payment file are processed for payment, while incorrect records are sent back to the respective Ministry or Department for necessary corrections.
- ii. Sharing of De-seeded Aadhaar protocol: Under this system, NPCI provides de-seeded Aadhaar data to PFMS, which in turn is shared with ministries/ departments through their external systems. With this implementation, Ministries can now exclude de-seeded Aadhaar records from their payment files thereby reducing credit failures.
- 4. Although these protocols have been implemented by most of the major DBT external systems—such as PAHAL, PM-KISAN, and NSP—there are still some external systems (list enclosed in Annexure I) that have yet to implement either or both of the protocols.

5. In view of the above, your kind intervention is requested to ensure that the concerned external systems take the necessary steps to facilitate the seamless implementation of the aforementioned protocols.

Subject: Sharing of Aadhaar-Seeded Data with External System.

Direct Benefit Transfer (DBT) payments are facilitated through the PFMS IT platform. PFMS develops new protocols from time to time for ease of beneficiary validations, timely payments and reducing payment failures. PFMS had developed a protocol for sharing Deseeded status of beneficiaries with the external systems.

- 2. To minimize payment failures and enhance system efficiency, PFMS has developed a new protocol whereby status of **Aadhaar-Seeding** is obtained on daily basis from the NPCI
- 3. External Systems may obtain the daily **Aadhaar-Seeding** status of beneficiaries of their respective schemes directly from the PFMS.
- 4. In this regard, Ministry/Department may issue necessary directions to the technical resources of their respective External Systems to avail daily seeding status. Following officials may be approached for getting required technical integration document/ SoP to avail facility of getting daily **Aadhaar-Seeded** information.

Status as on 4th June, 2025

Aadhaar Deseeding Protocol: Analysis of DBT transactions from external systems that could have been prevented from rejection / return if this protocol was implemented.

Status of Implementation of sharing of De-seeded Aadhaar with external systems processing DBT transactions (started with effect from 05.02.2024).

- (i) Before implementation of this protocol the total credit failure due to 'Aadhaar number de-seeded from NPCI mapper by bank' reason was 3.1 crore in the FY 2023-24 out of total no of 4.93 crore credit failures.
- (ii) After implementation of this protocol total credit failure under this reason has reduced to .94 crore in FY 2024-25 out of total no of 3.26 crore credit failures.
- (iii) This reduction is mainly due to implementation of this protocol under major external system particularly under PAHAL, PMKISAN etc.
- (iv) Presently, the external systems under which this protocol is implemented constitute more than 97% of Aadhaar based DBT transactions processed.
- 2. List of balance major external systems which has yet to implement this protocol is below. Credit failure due to 'Aadhaar number de-seeded from NPCI mapper by bank' in these systems are also indicated against their names in the following list.
