## **CIRCULAR**

Whereas, in reference to the aforementioned letter regarding the issuance of seniority, it has been observed that, after the apportionment of manpower between the Union Territory (UT) of Jammu & Kashmir and the Union Territory (UT) of Ladakh, the separate seniority list of gazetted employees in the Sheep Husbandry Department has not been maintained as on date.

Whereas, a seniority list of the Veterinary Assistant Surgeons in the Sheep Husbandry Department, UT of Ladakh is being carved out of the *Government Order No. 68-ASH of 2021, dated 06.04.2021*. Additionally, the employees appointed vide *Government Order No. 59-ASH of 2019, dated 22.04.2019, and Government Order No. 89-ASH of 2019, dated 08.07.2019*, have also been included in this list.

**Therefore**, a tentative seniority list of Veterinary Assistant Surgeons (UT Cadre) in the Sheep Husbandry Department, UT of Ladakh, as of 30-06-2025, is hereby notified, and attached as **Annexure 'A'** to this circular.

If any officer is aggrieved by their assigned position or not included in the tentative seniority list, they should submit their representation with supporting documents within 15 days from the date of issuance of this circular.

In case an officer chooses not to file any objection, it shall be construed that there is nothing objectionable against the seniority position. The final seniority list of officers in the Sheep Husbandry Department, UT of Ladakh, shall be issued accordingly with the approval of the Competent Authority.
