Pursuant to the instructions of the Union Home Secretary, conveyed by the Ministry of Home Affairs, GoI, *vide* letter dated 17.07.2025 referred above, a Committee under the Chairmanship of **Shri Sanjeev Khirwar, IAS, Principal Secretary, UT of Ladakh** is hereby constituted to review the matters pertaining to *Nautor land* and other land related issues, as well as, review the LAHDC Act, 1997. - (a) review issues pertaining to *Nautor land* and such other land related issues in the Union territory of Ladakh, strictly keeping in mind the interest of the people of Ladakh and submit a report in 04 weeks.
  - (b) review the LAHDC Act, 1997 and submit a report to strengthen the Councils.
3. The Committee shall also be assisted by the Deputy Commissioners / CEO, LAHDC, Leh & Kargil and the Asst. Commissioner Revenue, Leh and Kargil; in its functions. The Committee shall be serviced by the General Administration Department, UT of Ladakh.


