Subject: Release of 1st tranche of Central assistance for the year 2025-26 for implementation of projects under Watershed development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0) in the UT of Ladakh-reg.

Sanction is hereby accorded to the release of funds to the tune of ₹ 3.87 Crore (Rupees Three Crore Eighty Seven Lakh only) in favour of Director, Rural Development & Panchayati Raj Ladakh for further release to the Project Managers, WDC-PMKSY 2.0 (ACDs), Leh & Kargil for implementation of approved projects Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) 2.0 for the FY 2025-26.

The release of funds is however, subject to the fulfillment of following terms & conditions: -

1. The implementing agencies shall be responsible for utilizing the funds after strictly following all the codal formalities/procedures currently in vogue, adherence to the provisions of GFR-2017 related to CSS and provisions contained in the guidelines of WDC-PMKSY 2.0.
2. The funds are utilized for the purpose for which it has been released and no diversion of funds for any other purpose is allowed at any level.
3. The implementing agencies shall furnish the utilization certificate along-with audited statement of accounts/red accounts etc. after utilization of the funds.
4. The implementing agencies shall maintain proper account of expenditure and a separate cashbook for the scheme as already in vogue.
5. Interest accrued, if any, shall be part of the release and to be utilized on the approved components of WDC-PMKSY 2.0.
6. The Administrative expenditure under the projects should not exceed the ceiling of 10% of the actual expenditure.
7. The funds should be transferred through PFMS only.

The Joint Director, Finance, Rural Development Department UT of Ladakh shall set-up the limit on PFMS an amount of ₹ 3.87 Crore (Rupees Three Crore Eighty Seven Lakh only) to the Director Rural Development & Panchayati Raj Department, Ladakh for further release to the child agencies.
