Notification

Ladakh, the 5th of August, 2025.

S.O. 97_In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi Notification no; S.O. 5088 (E) dated 1st November 2022, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of **Joint Director Fisheries** in the Ladakh Fisheries Department, namely:

1. Short title and commencement:

- a. These rules may be called the Ladakh Administration, **Joint Director Fisheries** in the Ladakh Fisheries Department Recruitment Rules, 2025.
- b. These rules shall come into force from the date of their publication in the Official Gazette.

2. Number of posts, classification and Level in the Pay Matrix:

The number of said posts, its classification and level in the Pay Matrix attached hereto shall be as specified in column '2', '3'& '4' of the Schedule annexed hereto.

3. Method of recruitment, age limit, and qualifications:

The method of recruitment to the said post, age limit, qualifications and other matters relating to said posts shall be as specified in columns 5 to 13 of the Schedule annexed hereto.

4. Provision for Resident Criteria for the appointment by direct recruitment:

The eligibility for appointment will be subject to residency requirements prescribed in any Act, Rule, Regulation or Order in force in the Union Territory of Ladakh.

5. Disqualification: No person,

- 1. who has entered into or contracted a marriage with a person having a spouse living;
- 2. who having a spouse living has entered into or contracted a marriage with any person (s) shall be eligible for appointment to the said post;

Provided that the Lieutenant Governor (Administrator) of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person (s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

6. Power to relax:

Where the Lieutenant Governor (Administrator) is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

7. **Savings:**

Nothing in these rules shall affect reservations, relaxation in age-limit and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes, and the other special categories in accordance with the Rules, Instructions or Orders issued by the Administration of Union Territory of Ladakh.

Sc.) or (i) Aquatic Biology from a recognized University or Institute. Five years experience in Fisheries (ii) Aquaculture practices. **Standard Note:** Where iuniors who have completed their qualifying/eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying Ieligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some organization/department of the Central Government shall ordinarily not exceed three years.
