Whereas, as per the Jammu and Kashmir Reorganization Act 2019, the Union Territory of Ladakh has been established.

Whereas, as per SRO 698 dated 25.10.2019, a total of 2,179 Non-Gazetted posts of various categories have been allocated to the Health & Medical Education Department, Union Territory of Ladakh by the erstwhile state of Jammu & Kashmir.

Whereas, in reference to the Jammu and Kashmir Reorganization Act 2019, the Union Territory of Jammu and Kashmir has issued an apportionment order in favor of the officers/officials who have opted for UT-Ladakh, vide Government Orders No. 1212-JK(GAD) of 2021, 505-JK(GAD) of 2022, 1254-JK(GAD) of 2022, and 486-JK(GAD) of 2023, dated 15.11.2021, 05.05.2022, 17.10.2022, and 17.04.2023, respectively.

Whereas, as per the directions from this Directorate, the Chief Medical Officers/Deputy Chief Medical Officers, Leh and Kargil, have submitted the service biodata of all the Union Territory cadres, Divisional cadres, and their feeding cadres for the formulation of their cadre-wise seniority list.

Whereas, the 1st Tentative Seniority List of Senior Assistants was circulated vide this Directorate's Order No: 295 DHSL of 2024, dated 01.05.2024, for seeking comments/objections, if any, from the concerned parties.

Whereas, the Ministerial staff of Dy. Chief Medical Officer, Leh, has submitted an objection regarding the framing of a single seniority list for 2210 and 2211 staff.

Whereas, vide Endorsement No: 19032 A/42/2024-EST SEC(DHS) 1010-1012, dated 22.05.2024, this Directorate forwarded the same to the Chief Medical Officer, Leh, and Deputy Chief Medical Officer, Leh, for comments/submission of a para-wise reply along with documentary evidence.

Whereas, in response to the above reference, the Chief Medical Officer, Leh, submitted the reply for the same vide letter No: CMOL/EST/277, dated 31.05.2024. However, the Deputy Chief Medical Officer, Leh, has failed to submit the reply for the same.

Whereas, vide this Directorate's communication No: 19032 A/42/2024-EST SEC(DHS) 1362, dated 06.06.2024; 19032 A/42/2024-EST SEC(DHS) 1625, dated 18.06.2024; and 19032 A/42/2024-EST SEC(DHS) 2529, dated 13.07.2024, multiple reminders have been sent for the same.

Whereas, In response, vide letters No: DFWBL/L/558, dated 11.06.2024, DFWB/L/636, dated 25.06.2024; and DFW/L/919, dated 19.08.2024, the Deputy Chief Medical Officer, Leh, submitted replies without proper justification and evidence.

Whereas, on the basis of the above, vide letter No: 9032 A/42/2024-EST SEC(DHS), dated 13.09.2024, this Directorate once again directed the Deputy Chief Medical Officer, Leh, to submit the reply with proper justification along with documentary evidence. In response, the Deputy Chief Medical Officer, Leh, submitted a reply vide letter No: DFW/L/964, dated 17.09.2024; however, the issue remains unresolved.

Whereas, on 21.12.2024, all the ministerial staff of the Health Department, Leh district, submitted a joint representation requesting the finalization of the seniority list and the grant of promotion against the vacant posts

Whereas, vide efile No: 19032 A/42/2024-EST SEC(DHS), this Directorate forwarded the same to the Chief Medical Officer and Deputy Chief Medical Officer, Leh, for comments.

Whereas, in response, both the Chief Medical Officer and Deputy Chief Medical Officer, Leh, have reached a consensus on the issue of a common seniority list for the Health and Family Welfare ministerial cadres.

Whereas, On the basis of which with the approval of the Competent Authority the 2nd Tentative Seniority list of Senior Assistant was circulated vide this directorate order No: 31 DHSL of 2024 dated: 3.02.2025 for seeking comments/objections if any from the concerned.

Whereas, the Deputy Chief Medical Officer, Leh has against submitted the objection vide letter no. DFW/L/261-62 dated: 15.02.2025, on the same subject matter.

Whereas, this directorate has sought comments / reply from Chief Medical Officer, Leh and Deputy Chief Medical Officer, Leh via e-file No: 19032 A/42/2024-EST SEC(DHS) and submitted their reply.


