

Dated 25th August, 2025Dear *Madam/Sir*

As you may aware, the Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 came into force w.e.f. 08-04-2025. Further, in exercise of the powers conferred under Section 108B of the Act, 1995, Ministry of Minority Affairs, Gol, has notified the Unified Waqf Management, Empowerment, Efficiency and Development Rules, 2025 on 03-07-2025.

2. As per the Rule 3 (7) of the the Unified Waqf Management, Empowerment, Efficiency and Development Rules, 2025 which stipulates that "Every State Government shall appoint an officer not below the rank of Joint Secretary to that Government as the Nodal Officer and shall establish a centralised support unit, in consultation with the Central Government for providing assistance in streamlining uploading details of waqf and properties thereof, registration, maintenance of accounts, audit and other related activities of the waqf and the Board"

3. In this regard, it is essential that each State/UT Government designate a Nodal Officer not below the rank of Joint Secretary and also establish such centralised support unit to ensure effective coordination and implementation of the framework laid down in the Rules. The designated Nodal Officer will serve as the principal liaison for communication between State Government, State Waqf Board, and Ministry of Minority Affairs.

4. I would be grateful if you kindly designate a Nodal Officer not below the rank of Joint Secretary for your State/UT at the earliest. The details of the Nodal Officer, including **Name, Designation, Contact Number, and email address etc.**, may kindly be shared with this Ministry at the earliest.
