CIRCULAR

A communication has been received regarding the issuance of a seniority list of Non-Gazetted (Divisional/UT Cadre) employees of the Fisheries Department, UT of Ladakh.

It has been observed that, after the apportionment of manpower between the Union Territory of Jammu & Kashmir and the Union Territory of Ladakh, a separate seniority list of Non-Gazetted employees in the Fisheries Department has not been maintained to date.

As per *Rule 10 of S.O. 08*, *dated 24.03.2022*, the responsibility for maintaining an up-to-date and final seniority list of the Members of the Service rests with the Chief Executive Officer for District Cadre posts and with the Administrative Department for all other posts;

Therefore, a tentative seniority list of Non-Gazetted (Divisional/UT Cadre) employees in the Fisheries Department, UT of Ladakh, as on 31.08.2025, is hereby notified (in terms of S.O. 114, dated 25.10.2022, Ladakh Fisheries (Subordinate) Service Recruitment Rules, 2022) and attached as Annexure 'A', 'B', 'C', 'D', 'E' and 'F' to this Circular.

Accordingly, all officials of the **Fisheries Division** of the Department of Animal / Sheep Husbandry and Fisheries, UT of Ladakh, are hereby given an opportunity to submit representations to the Administrative Department. In case any official is aggrieved by their assigned position or by non-inclusion in the tentative seniority list, they may submit their representation along with supporting documents within 15 days from the date of issuance of this Circular.

In case no objection/representation is received within the stipulated time, it shall be presumed that the concerned officials have no objection to their assigned seniority position. The final seniority list of officials of the Fisheries Division of the Department of Animal / Sheep Husbandry and Fisheries, UT of Ladakh, shall thereafter be issued accordingly.
