- 1. The appointee shall report to the Department of Law and Justice within a period of 21 days from the date of issuance of this order and if she fails to join within the stipulated time, she shall forego her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.
- 2. The service conditions of the above-appointed Junior Assistant shall be governed by the Ladakh Legal *(Subordinate)* Service Recruitment Rules, 2021.
- 3. If any adverse report about her character and antecedents is received from the Director General of Police, Criminal Investigation Department, Ladakh;

Any qualification certificate / reserved category certificate / experience certificate (wherever applicable) is found false or fake on verification from the concerned issuing authorities;

In such cases, the appointed candidate shall have no right to claim her appointment and her appointment shall be deemed to have been cancelled ab initio.

4. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report/genuineness of the certificates in

respect of the above para (3) is received.

5. The appointees shall be on probation for a period of two years. The conditions of probation as prescribed in the Union Territory of Ladakh Legal (Subordinate) Service Recruitment Rules, 2021 and other rules / instructions issued in this regard by the Central Government/Administration of Union territory of Ladakh shall be applicable to the appointee.

6. The appointed candidate shall have to serve anywhere within the territorial/Administrative jurisdiction of the Union territory of Ladakh.
