Consequent upon the acceptance of Offer of Appointment vide OM No: Secy(FCS&CA)/A/2093/2024/2051-54 Dated: 21/10/2025, Sanction is hereby accorded to the temporary appointment of Sh. Abazar, S/o Late Tohir Hussain (Ex. Employee) of FCS&CA, Kargil, R/o Parkachik, Taisuru Block, Kargil as Chowkidar in the pay level of SL-1(14800-47100), in the Department of Food, Civil Supplies& Consumer Affairs in the district Kargil, on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Director, FCS&CA, UT Ladakh within a period of 21 days from the date of issuance of this order and shall be allowed to join duty only on production of the following documents/certificates (in original) to be verified subsequently:

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Residence/Domicile Certificate
- iv. Health Certificate from the Concerned Chief Medical Officer
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under the self-employment scheme from the Employment Department/DIC
- vii. All other relevant documents are as required under SRO-43 of 1994.

The appointment of the appointee shall further be subject to the following conditions: -

(a) That the appointee shall give an undertaking in the shape of an Affidavit

to the effect that: -

- (i) In case an adverse report of the appointee, about the Character and Antecedents is received from the CID wing of UT Ladakh, to whom a reference shall be made by the Director FCS&CA, UT Ladakh, he shall have no claim on his appointment as Chowkidar/Orderly and his appointment, as such, shall be deemed to have been cancelled ab-initio;
- (ii) If, on verification, the genuineness/validity of the Documents from the concerned issuing authority is found fake/forged, the claim of the appointee shall also be deemed to have been cancelled ab initio, and the legal action as warranted under rules shall be initiated against him.
- (b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i)&(ii) above is received in his favor.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) If the appointee fails to join within a period of 21 (twenty-one) days from the date of issuance of this order, he shall forgo his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
