NOTIFICATION

Ladakh, the 12th of November, 2025

S.O. 129.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India read with the Govt. of India, Ministry of Home Affairs, New Delhi Notification No. S.O 5088(E) dated 1st November,2022 and in supersession of all earlier notifications on the subject matter, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of Lecturer-I (Electrical Engineering) in the Ladakh Technical Education & Skill Development Department (Polytechnic Sector), namely:

1. Short title and commencement: -

- (a) These rules may be called the Ladakh Administration, Lecturer-I (Electrical Engineering) in Ladakh Technical Education & Skill Development Department Recruitment Rules, 2025.
- (b) These rules shall come into force from the date of their publication in the official

2. Number of posts, classification and Level in the Pay Matrix: -

The number of said post, its classification and level in the pay Matrix attached hereto shall be as specified in column 2, 3 & 4 of the Schedule annexed hereto.

3. Method of recruitment, age limit, other qualifications: -

The method of recruitment, age limit, qualifications, and other matters relating to said posts shall be as specified in paras 5 to 13 of the Schedule annexed hereto.

4. Provision for Resident Criteria for appointment by direct recruitment: -

The eligibility for appointment will be subject to residency requirements prescribed in any Act, Rule, Regulation or Order in force in the Union territory of Ladakh.

5. Disqualification: -

No person,

(a) who has entered into or contracted a marriage with a person having spouse living;

OR

(b) who having a spouse living, has entered into or contracted a marriage with any person(s) shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor (Administrator) of Ladakh may if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

- **6. Power to relax:** Where the Lieutenant Governor Union Territory of Ladakh (Administrator) is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.
- **7. Savings: -** Nothing in these rules shall affect reservations, relaxation in age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, and the other special category of persons in accordance with the instructions or orders issued by the Administration of Union Territory of Ladakh.



years for persons holding the feeder post of Lecturer-II (Electrical Engineering) on regular basis on the date of notification of these rules possessing qualification of degree in Engineering or equivalent in the respective branch from a recognized University/Institute or 3 years diploma with 60 percent marks in respective branch of Engineering from a recognized Board/Institute.

Note 2: In case suitable candidates from the category of Lecturer-II (Electrical Engineering) are not available, the candidates holding posts of Demonstrator (Electrical Engineering) in Level-6D in the pay matrix on regular basis on 31.10.2019 with six (06) years of regular service in the grade rendered after appointment thereto on a regular basis for persons holding the Bachelor Degree in Relevant / Appropriate branch of Engineering or with (08) years of regular service in the grade rendered after appointment thereto on a regular basis for persons holding 3 years diploma with minimum of 60 percent marks in relevant / Appropriate branch of Engineering shall be considered for promotion to the post of Lecturer-I (Electrical Engineering).

Note 3: Note 2 shall not be applicable to direct recruits / promotees appointed in the grade of Demonstrator in the Union Territory of Ladakh after 31st October 2019.

Deputation (Including Short Term Contract): -

Officers under Central Government/ State Governments/ Union Territory Administrations/Public Sector Undertakings/ Universities/Recognized Institutes/Recognized research institutions/ Autonomous Organization/ Statutory Organization:

(a)(i) Holding analogous post on a regular basis in the parent cadre/department; or

(ii) with 2 years of regular service in post in the Level-7 in the pay matrix or equivalent in the parent cadre/ department; and

(b) Possessing the following educational qualifications and experience:

(i) Bachelor Degree in Electrical Engineering/ Electrical and Electronics Engineering (Bachelor of Engineering/Bachelor of Technology) with First class or equivalent from a recognised University/Institute.

(ii) Six years of professional experience in Electrical Engineering or teaching in Electrical Engineering.

Note 4: If a class or division is not awarded, minimum of 60 percent marks in aggregate shall be considered equivalent to

first class or division. If a grade point is adopted the Grade Point average will be converted into equivalent marks as below:

Grade point	Equivalent
6.25	55 percent
6.75	60 percent
7.25	65 percent
7.75	70 percent

Standard Note:

Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying /eligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years. The Maximum age limit for appointment by deputation shall be Not exceeding 56 years as on the last date of receipt of applications.
