Consequent to the instructions received from the Ministry of Home Affairs vide the references cited above and in supersession of the order NO: 29/Adsecy-F of 2021 Dated 29.12.2021, the Lieutenant Governor, UT of Ladakh, is pleased to re-delegate/ modify powers to the following Authorities to the extent mentioned against each, in order to exercise powers conferred under Rule 12(3) of the Delegation of Financial Power Rules 2024 read with the Ministry of Home Affairs letters referenced above subject to the rules, restrictions, and scales specified in the GFR 2017, D.F P.R 2024, and other orders/instructions issued by the Government of India/Administration of UT Ladakh from time to time.

**Note 1:** The powers for awarding negotiated or single tender (contract/purchase) or proprietary contracts and agreements up to Rs. 10.00 Crores shall remain with the Lieutenant Governor.

**Note 2:** The Financial power including sanction for expenditure of works at S.No 5& 6 shall be exercised in consultation with Finance Secretary/Finance Department of UT Ladakh.

**Note3**: All new proposals for appraisal and approval of new projects/schemes in relevant forms as specified in the Department of Expenditure (MoF) O.M No. 24(35)/PF-II/2012 dated 05.08.2016 shall be submitted to the Ministry of Home Affairs in terms of for necessary approval.

**Note 4**: All the proposals to be submitted to MHA for appraisal of new projects/Schemes including Administrative Approval and Expenditure sanction shall be routed through the Planning Development & Monitoring Department, UT of Ladakh.

**Note 5**: All ongoing schemes/project, works (including the works where the administrative approval has already been accorded or tendered or completed) prior to the issuance of the Ministry of Home Affairs letter No. 15020/11/2024-Plg.Cell dated 19.09.2025, shall continue to be governed under the earlier delegation of powers.

## These delegated financial powers shall be subject to the following conditions:

- 1. All Codal formalities should be followed as prescribed under the relevant rules such as GFRs, DFPRs, CPWD code/Works Manual, economy instructions and other orders/guidelines/instructions issued by various Ministries/Departments of Govt. of India viz. MoF, MHA, MoCA, MeitY, MoHUA, DoPT, D oPPW, CVC etc. from time to time.
- 2. Procedures for procurement of goods and services laid down in the Manual in Policies and Procedures for Purchase of Goods, for procurement of Services and works, issued by Ministry of Finance will be complied with.
- 3. The valid approvals from the competent authority should exist before procurement action is initiated.



**4.** Budgetary provisions should exist in the financial year concerned (where ever applicable).
