Subject: Extension of Early Bird Incentive (EBI) under the Ladakh Electric Vehicle and Allied Infrastructure Policy, 2022.

Order No. 20-Trans(UTL) of 2025 Dated: 28.11.2025

WHEREAS, the Ladakh Electric Vehicle and Allied Infrastructure Policy, 2022, notified vide order No. 09-Trans(UTL) of 2022 dated 17.08.2022, provided an Early Bird Incentive (EBI) for one year from the date of notification of the said policy, whereby subsidy/rebate on ex-showroom prices of various categories of Electric Vehicles is provided by the Transport Department of Ladakh; and

WHEREAS, post-expiry of the said incentive, Electric Vehicle adoption remained low in the UT of Ladakh. However, with the notification of the Ladakh Vehicle Scrapping Policy, 2025, besides, establishment of Registered Vehicle Scrapping Facility (RVSF) and installation of EV charging stations in the UT, the constraints impeding Electric Vehicle uptake are now being addressed; and

WHEREAS, the Planning, Development and Monitoring Department has approved subsidy under the said policy, to be utilized by the Transport Department for those persons who intend to avail the Early Bird Incentive (EBI), as provided in the policy; and

WHEREAS, on the demand of the transporters/stakeholders of UT of Ladakh, a need has been felt for extending the Early Bird Incentive (EBI) under the said policy, so that the benefits are availed by these transporters/stakeholders; and

WHEREAS, in terms of Para 7.1 of the Operational Guidelines contained in the Ladakh Electric Vehicle Policy and Allied Infrastructure Policy, 2022, the Administration of UT of Ladakh is empowered to amend or extend policy provisions.

NOW THEREFORE, it is hereby ordered that the Early Bird Incentive (EBI), provided under the Ladakh Electric Vehicle and Allied Infrastructure Policy, 2022, is extended upto 31st March, 2027, with immediate effect.
