The following proposals are approved for implementation of SAMARTH digital platform:

1. **Appointment of Nodal Officer:** The District Panchayat Officer Leh (Sh. Aqeel Sajjad JKAS) is hereby nominated as the designated as Nodal Officer for the roll out and implementation of the Samarth portal.
2. **Training and sensitization of panchayat functionaries** for the effective use of the portal shall be undertaken through ongoing training and capacity buildings programmes under the RGSA scheme.
3. **Integration of all gram Panchayats:** The District Panchayat Officer Leh/Kargil, along with the officials at block and panchayat level including the Block Coordinators under RGSA of the respective districts, shall be responsible for ensuring integration of all Gram Panchayats under the portal.
4. **Training and support:** The National Informatics Centre (NIC) UT Ladakh, shall provide necessary training and technical support to the concerned officials for smooth implementation.
5. **Regular progress reports** on the implementation and functioning of the SAMARTH digital platform shall be obtained from the respective District Panchayat Officers and submitted to this Directorate for review.
