In pursuance of Advertisement Notice No: A/5/2021-S&TW-SEC-Part (2)/2416-2422, dated 17/10/2025, and based on the selection of the UT Level Selection Committee for the engagement of contractual staff under Mission Vatsalya and Mission Poshan 2.0 for the posts of Program Officer (SARA), Program Assistant (SARA), Assistant-cum-Data Entry Operator (SCPS), State Consultant - Health & Nutrition, Secretarial Assistant/DEO, and Office Messenger, sanction is hereby accorded to the temporary appointment of the following candidates listed at Annexure "A" to this order for the FY 2025-26, subject to satisfactory annual performance appraisal.

The candidates listed at Annexure "A" are appointed for the posts indicated against Mission Vatsalya and Mission Poshan 2.0 purely on a contractual basis. The terms of reference and remuneration shall be governed by the respective Mission Guidelines.

The selected candidates shall report to the Office of Mission Vatsalya and Mission Poshan 2.0, near the ARTO Office, Agling Leh with the requisite original documents, within one week from the date of issuance of this order.

The engagement shall be subject to the following terms & conditions:

## Terms & Conditions:

- 1. The appointment is purely contractual and continuation or renewal of the contract shall not confer any right to claim regularization or permanent absorption against the post.
- 2. The appointment is upto FY 2025-26 and shall be subject to satisfactory annual performance appraisal and vigilance clearance.
- 3. The selected candidates shall execute an agreement through a prescribed affidavit, duly sworn before the Judicial Magistrate, affirming that he/she shall not claim any right to permanent absorption or regularization in the Administration at any stage.



- 4. The appointees shall be entitled to 12 days leave in a calendar year after which remuneration shall be deducted on a pro-rata basis.
- 5. The appointees must join within 07 days from the date of issuance of this order. Failure to join within the stipulated time period without a justifiable reason accepted by the Department shall result in cancellation of the engagement order ab initio for the concerned candidate and the waitlist shall be operated.
- 6. The candidates shall be allowed to join on production of the following original certificates.
  - i. Qualification Certificates viz. Degree/Mark sheet.
  - ii. Experience Certificate.
  - iii. Age Certificate.
  - iv. Certificate from the concerned authority to the effect that no loan under self-employment scheme of the Govt. has been taken by the concerned.
