## **NOTIFICATION**

### Ladakh, the 29th of December, 2025

- **S.O. 150.** In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi Notification No. S.O. 5088(E) dated 01<sup>st</sup> November, 2022, with prior consultation of the Union Public Service Commission; and in supersession of the Notification No. S.O. 35 dated 25.06.2024, published in the Official Gazette dated 25.06.2024; the Lieutenant Governor (Administrator) of the Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of **Assistant Engineer (Civil)** in the Public Health Engineering and Irrigation and Flood Control Department of the Administration of Union territory of Ladakh, namely:—
- 1. Short title and commencement.— (1) These rules may be called the Ladakh Administration Assistant Engineer (Civil) in Ladakh Public Health Engineering and Irrigation and Flood Control Department Recruitment Rules, 2025.
- (2) These rules shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and Level in the Pay Matrix. —The number of the said posts, its classification and the Level in the Pay Matrix attached thereto shall be as specified in paras 2, 3 & 4 of the *Schedule* annexed hereto.
- **3. Method of recruitment, age limit and qualifications.** The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in paras 5 to 13 of the *Schedule* annexed hereto.
- **4. Provision for Resident Criteria for appointment by direct recruitment.** The eligibility for appointment will be subject to residency requirements prescribed under any Act, Rule, Regulation or Order in force in the Union territory of Ladakh.



- **5. Disqualification.** No person,
  - (1) who has entered into or contracted a marriage with a person having a spouse living;
    OR
  - (2) who, having a spouse living, has entered into or contracted a marriage with any person(s), shall be eligible for appointment to the said post:

*Provided* that, the Lieutenant Governor (Administrator), Union territory of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for doing so, exempt any person(s) from the operation of these rules.

- **6. Power to relax.** Where the Lieutenant Governor (Administrator) of Union territory of Ladakh is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of person(s).
- **Savings.** Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and the other special categories in accordance with the Rules, Instructions or Orders issued by the Administration of Union territory of Ladakh.
