**S.O. 151** — In exercise of the powers conferred by sub-section (2) of Section 4 of the Census Act, 1948 (Act 37 of 1948), The Lieutenant Governor of Ladakh hereby appoints categories of officers shown in column (2) of the below mentioned table as Census Officers with designations and the Jurisdiction shown against each category in columns (3) and (4) of the table respectively for the purpose of the Census of India 2027: -

4.	Sub-Divisional Magistrates	Sub-Divisional Census Officers	Within the limit of their respective Sub-Divisions.
5.	Tehsildars	Charge Census Officers	Within the limit of their respective Tehsils.
6.	Naib-Tehsildars	Additional Charge Census Officers	Within the limit of their respective Niabat.
7.	Executive Officers of the Municipal Committees.	Charge Census Officers	Within the limit of their respective Municipal Committees.

The Lieutenant Governor of Ladakh in exercise of the powers under sub-section (3) of section 4 of the Census Act, 1948 (Act 37 of 1948) is further please to authorize the aforementioned Officers to sign declarations for any local area within their respective jurisdictions in connection with Census 2027.

The Lieutenant Governor of Ladakh in exercise of the power conferred by sub-section (4) of section 4 of the Census Act, 1948 (Act 37 of 1948) is also pleased to delegate the power of appointing Census Officers conferred by sub-section (2) of Section 4 of the said Act to the Principal Census Officers(s) (Deputy Commissioners) within their respective jurisdictions in connection with Census 2027.


