**Subject: - Compliance with directions of the Hon'ble Rajasthan High Court, as reaffirmed by the Hon'ble Supreme Court, regarding removal of cattle and stray animals from Highways.**

#### ORDER

Whereas, the Hon'ble Rajasthan High Court at Jodhpur, vide order dated **11th August, 2025** passed in **D.B. Civil Writ Petition No. 14726 of 2025**, issued directions for removal of all cattle and other stray animals from **State Highways, National Highways and National Expressways**; and

Whereas, the Hon'ble Supreme Court of India, in **Suo Motu Writ Petition (Civil) No. 5 of 2025**, titled "*City Hounded by Strays, Kids Pay Price*", has reaffirmed the aforesaid directions and directed all Municipal Authorities, Road & Transport Departments/Public Works Departments of States/UTs and the National Highways Authority of India (NHAI) to ensure strict compliance thereof; and

Whereas, Municipal Committee, Leh is duty-bound to ensure public safety and prevent road accidents caused due to the presence of stray cattle and animals on highways within its jurisdiction;

**Now, therefore, in compliance with the aforesaid directions of the Hon'ble Courts, it is hereby ordered that:**

1. All cattle and other stray animals shall be immediately removed from the State Highways and National Highways falling within the municipal limits of Municipal Committee, Leh.
2. The concerned field staff of Municipal Committee, Leh, including Sanitation/Enforcement teams, shall conduct regular drives and continuous monitoring to ensure that no stray cattle or animals are found roaming on the said highways.
3. Cattle owners, if identified, shall be proceeded against as per the applicable municipal laws, rules, and by-laws, and penalties shall be imposed wherever warranted.
4. Necessary coordination shall be maintained with the Police Department, Animal Husbandry Department, PWD/R&B, and other concerned agencies to ensure effective & sustained compliance.
5. This order shall come into **immediate effect** and shall remain in force until further orders.

All concerned are directed to ensure **strict compliance** of this order in letter and spirit.
