**Subject: - Constitution of Highway Patrol Team for removal of stray cattle/animals from roadways.**

**ORDER**

In compliance with the directions of the Hon'ble Court regarding constitution of dedicated highway patrol teams for continuous surveillance and immediate response to incidents involving stray cattle and other animals on roadways;

**It is hereby ordered that:**

1. A Highway Patrol Team is hereby constituted by the Municipal Committee, Leh, comprising Khilafwarzi Assistants of MC Leh and one nominated member from each Leh-based Animal Welfare Organisation.
2. The team shall conduct regular surveillance and immediate response to reports of stray cattle or other animals obstructing State Highways, National Highways, and major roads within the municipal jurisdiction of Leh.
3. The patrol team shall function on a 24x7 basis, with duties assigned in shifts.
4. The team shall coordinate with the local Police Stations, Veterinary Officers, and other concerned departments for effective removal and management of stray animals.
5. The functioning of the patrol team shall be supervised by the Seniormost Khilafwarzi Assistant, MC Leh.
6. The Highway Patrol Team shall submit a monthly report to the Municipal Committee, Leh, detailing the action taken for removal of stray cattle and other animals from roadways.

This order shall come into force **with immediate effect**.
