**The Terms of Reference (ToR) of the Committee shall be as under: -**

1. Provide overall policy guidance and direction for implementation of M-CADWM in UT of Ladakh.
2. Approve annual action plans, project proposals and modifications thereof under the scheme.
3. Ensure convergence with other schemes such as PMKSY, RKVY, VB-G RAM G (earlier known as MGNREGA) and State/UT sector schemes etc.
4. Monitor physical and financial progress of projects and resolve inter-departmental issues.
5. Review adoption of modern irrigation practices, water-use efficiency measures and participatory irrigation management.
6. Ensure compliance with guidelines issued by the Government of India from time to time.
7. Facilitate capacity building, use of appropriate technology and climate-resilient interventions suitable for Ladakh.
8. Ensure timely decision-making and optimal utilization of financial and physical resources.
9. Submit periodic progress reports to the Ministry of Jal Shakti / Government of India.
10. The constitution of the UT Level Steering Committee shall not involve any additional financial burden, as expenditure on meetings and related activities shall be met from existing budgetary provisions under M-CADWM or departmental resources. The Committee shall be serviced by the Agriculture Department.
