

**Notice for inviting applications for the post of Independent Member(s) to the Consumer Grievances Redressal Forum(s) (CGRF), one each for Jammu Power Distribution Corporation Limited (JPDCL), Kashmir Power Distribution Corporation Limited (KPDCL) and Ladakh Power Development Department (LPDD).**

The Joint Electricity Regulatory Commission for Union Territories of J&K and Ladakh (JERC-JKL) invites application from suitable person(s) for the appointment of **Independent Member(s)** in the Consumers Grievances Redressal Forum(s), one each for the Consumers of the JPDCL, KPDCL and LPDD to discharge various functions related to Redressal of Consumer's Grievances against Distribution Licensees as per the provisions of the *Joint Electricity Regulatory Commission for UT of Jammu & Kashmir and UT of Ladakh (Consumer Grievances Redressal Forum, Electricity Ombudsman and Consumer Advocacy) Regulations, 2023*.

The eligibility criteria, Qualification, Experience and monthly remuneration for the post of **Independent Member** is as under:

Bachelor's degree preferably in Engineering (Electrical / Mechanical/ Electronics/ Computer) / Law/ Public Administration / Journalism / Economics / Political Science or equivalent.	<ul style="list-style-type: none"><li>• 5 years of experience in power sector related matters.</li><li>• A retired civil servant of Additional Secretary level of UT of J&amp;K / Deputy Secretary level in Govt. of India ( i.e. of Level 12) <b>OR</b></li><li>• A retired Electrical Engineer not below the rank of Superintending Engineer having experience in distribution of electricity.</li></ul>

**The Independent Member(s) shall be engaged on the following terms and conditions:**

- The monthly remuneration shall be Rs. 30,000/-.
- The engagement shall be purely on contractual basis and shall not confer any right to claim regular appointment or continuation of contractual engagement in the Distribution Licensee or the Commission.
- The Independent Member shall be appointed initially for one year, extendable annually up to four additional years or till attaining the age of 65 years, whichever is earlier, however, each extension shall be accorded for one year, subject to annual performance review by the Commission.
- The Independent Member shall be entitled to avail 12 days Casual Leave in a calendar year.
- The Independent Member shall be entitled to TA/DA, as admissible to a Level-12 Officer of the UT of J&K, for official tours approved by the Chairman, CGRF.
- All other terms and conditions shall be as determined by the Commission from time to time.
- The **Scope of Work** and detailed terms and conditions are contained in **Annexure-I**, which shall form an integral part of this engagement.

**Term of Reference (ToR) for engagement of Independent Member(s) to the Consumer Grievances Redressal Forum(s) (CGRF) one each for Jammu Power Distribution Corporation Limited (JPDCL), Kashmir Power Distribution Corporation Limited (KPDCL) and Ladakh Power Development Department (LPDD)**

1. The name, location, e-mail address, telephone of Independent Member shall be widely published by the Distribution Licensee through newspapers from time to time, at least once in each quarter and shall be displayed on the website of the Distribution Licensees as well at all the offices of the Distribution Licensee including the office of the Commission. Such particulars shall also be intimated to the consumers through electricity bills by printing necessary message at appropriate place on the energy bills. The Distribution Licensee shall also give wide publicity to these particulars through electronic media. And, there should be no reservations to Independent Member on account of it.
2. The Licensee shall meet all the costs and expenses of the CGRFs including the cost of establishment and staff required to assist the Forum in the discharge of its functions under these Regulations. The licensee shall appoint a Nodal officer to act as the facilitating link between the Forum & the Licensee and also for fulfilling day to day requirements of CGRF.
3. No person shall be appointed and/or be entitled to continue as a Member if he/she:
  - has been adjudged as insolvent; or
  - has been convicted of an offence involving moral turpitude; or
  - has become physically or mentally incapable of acting as such member; or
  - has without reasonable cause refused or failed to discharge his functions for a period of at least three months; or
  - ceases to fulfil any of the conditions of his appointment as member; or
  - has acquired such financial or other interest that can prejudicially affect his functioning as a member; or
  - has conducted himself in a manner or has so abused his position as to render his continuance in office prejudicial to the public interest or to the objects and purposes of the Act.
  - has been guilty of proved misbehaviour.
  - has negligence towards his duties is established.

Provided further that the Independent Member appointed by the Commission shall be removed from his office only after the prior approval of the Commission as per the procedure laid in regulation *Joint Electricity Regulatory Commission for UT of Jammu & Kashmir and UT of Ladakh (Consumer Grievances Redressal Forum, Electricity Ombudsman and Consumer Advocacy) Regulations, 2023*.

4. Independent Member shall abide by all the regulations & Laws in force formulated by the JERC for J&K and Ladakh.
