Consequent upon the selection made by the Leh Autonomous Hill Development- Subordinate Service Recruitment Board (LAHD-SSRB) and with the approval of the Competent Authority / Appointing Authority, the following candidate is hereby appointed to the post of **Driver Grade-II , in the Rural Development Department of the Administration of Union territory of Ladakh, in Level-2 of pay matrix. (Rs.19,900-63,200)** and other allowances as admissible under Rules, with immediate effect:

The appointment shall be subject to the following **conditions**:

1. The appointee shall be on probation for a period of **two years** from the date of joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of his performance or conduct, he is considered unsuitable for further retention in service, or
 - b) He is otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointee has been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificate of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Rural Development Department (Subordinate) Service Recruitment Rules, 2021.

It is further ordered that:

1. The services of the above candidate appointed as **Driver Grade-II** is placed at the disposal of the Director, Rural Development Department, Ladakh for further deployment in the Sub-ordinate Offices of **Rural Development Department, Leh.**
2. The appointee shall report to the **Office of Director, Rural Development Ladakh,** for joining within a period of one (01) month, from the date of issuance of this Order, failing which his appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with his respective place of posting upon his deployment in the Sub-ordinate Office of **Rural Development Department, Leh.**

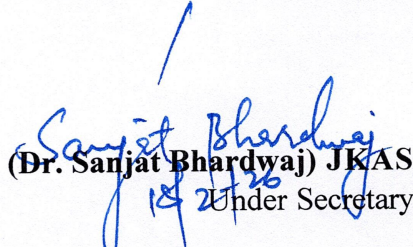
