The appointment shall be subject to the following **conditions**:

1. The appointee shall be on probation for a period of **two years** from the date of joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or
 - b) He/She is otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointee has been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificate of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Rural Development Department (Subordinate) Service Recruitment Rules, 2021.

It is further ordered that:

1. The services of the above candidate appointed as **VLW/MPW** is placed at the disposal of the Director, Rural Development Department, Ladakh for further deployment in the Sub-ordinate Offices of **Rural Development Department, Kargil**.
2. The appointee shall report to the Office of Director, Rural Development Ladakh, for joining within a period of one (01) month, from the date of issuance of this Order, failing which her appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with her respective place of posting upon her deployment in the Sub-ordinate Office of **Rural Development Department Kargil**.


