Mode of Deposition of Bid amount	The highest bidder in whose favour the bid is finally closed shall be required to deposit 75% of the total bid amount in official account of MC Leh by 28 th March 2026 and Remaining 25% bid amount shall be required to deposit within 2 months from the date of taking over the possession for which irrevocable bank guarantee from any nationalized/scheduled bank shall be given.
