Whereas, pursuant to the recommendations of the LAHDC-KSSRB, Kargil, (30) candidates were provisionally selected as **Class IV**, in School Education Department, UT Ladakh for District Cadre Kargil, in Level – SL1 of pay matrix (₹ 14800-47100).

Whereas, School Education Department UT Ladakh vide **Memorandum No. A/387/2024-EST SEC (GZ)-SED/1272-1280 dated: 03.02.2026** issued an offer of appointment to the candidates selected provisionally for the posts of **Class IV** with the directions to submit the acceptance undertaking within 30 days from the issuance of the said memorandum.

Whereas, in terms of instructions contained at para (15) in the Memorandum issued by the office of the Administrative Secretary, School Education Department, UT Ladakh, the candidates who fail to submit the undertaking within a period of 30 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Whereas, the Chief Education Officer, Kargil has vide letter No. Estt-25/DSSR/2026/884-86, dated: 25.02.2026 intimated that amongst (30) selected candidates, (27) candidates have submitted acceptance undertaking within the stipulated time i.e. by 02.03.2026, whereas (03) candidates mentioned at **Annexure 1** have not submitted undertakings within the stipulated time period of 30 days.

Now therefore, in light of the above, the offer of appointment issued in favour of the (03) candidates mentioned below for the post of **Class IV** in School Education Department, UT Ladakh, for District Kargil, is deemed to have been cancelled w.e.f. 03.03.2026.


