**Whereas**, School Education Department UT Ladakh vide **Memorandum No. A/319/2024-EST SEC (GZ)-SED/1289-1297 dated: 04.02.2026** issued an offer of appointment to the candidates selected provisionally for the posts of **Class IV** with the directions to submit the acceptance undertaking within 30 days from the issuance of the said memorandum.

**Whereas**, in terms of instructions contained at para (15) in the Memorandum issued by the office of the Administrative Secretary, School Education Department, UT Ladakh, the candidates who fail to submit the undertaking within a period of 30 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

**Whereas**, the Chief Education Officer, Leh, has vide letter No. Esstt-6/34442 dated 26.02.2026, intimated that amongst (38) selected candidates, (36) candidates have submitted acceptance undertaking within the stipulated time i.e. by 03.02.2026, whereas (02) candidates mentioned at **Annexure 1** have not submitted undertakings instead they

have submitted their written statements expressing their unwillingness to accept the post.

**Now therefore**, in light of the above, the offer of appointment issued in favour of the (02) candidates mentioned below for the post of **Class IV** in School Education Department, UT Ladakh, is deemed to have been cancelled w.e.f. 04.02.2026.
