1. The Appointee shall be on probation for a period of two year with effect from the date of their joining the post. During the period of probation, the appointee will be liable to be discharged from the service at any time without notice, If
  - (a) On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service.
  - (b) He/she is otherwise found ineligible or unsuitable to be retained in the service.

The appointment is subject to the verification of character/ marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Election (Subordinate) Service Recruitment Rules,2025.



2. The Expenditure towards his/her pay and allowance shall be debited against the head of "salaries" from the Budget Head associated with their respective place of posting upon their deployment in the Election Department.
3. The above appointee has been declared medically fit by the prescribed Medical Authority Vide Letter dated: 24.02.2026.
4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
5. It is further ordered that the appointee shall report to the Chief Electoral Officer/Secretary Election Department, UT Ladakh for joining within a period of one month from this issuance, failing which his/her appointment shall be deemed to have been cancelled.
6. The service of the above appointee is placed at the disposal of the Chief Electoral Officer/ Administrative Secretary Election Department, UT Ladakh, for further deployment in the Sub-ordinate Offices of the Election Department.
7. The appointment of the candidate shall be subject to the outcome of writ petition, if any pending before the competent Court of Law, which may not be presently within the knowledge of the Department.
