The appointment shall be subject to the following conditions:-

- The appointees shall be on probation for a period of two years with effect from the date of their joining to the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or
 - He / she is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointee has been declared medically fit by the Prescribed Medical Authority.
- This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union territory of Ladakh Cooperative (Subordinate) Service Recruitment Rules, 2021 and must possess the requisite qualification on the cut-off date of notification. All the documents for

validity and genuines shall be verified by the Additional Registrar, Cooperative Department, UT of Ladakh. If at any stage, it is found that the documents submitted by the appointee are found not valid / genuine, his/her appointment shall be terminated ab-initio.

It is further ordered that:

1. The services of the above candidate appointed as Orderly is placed at the disposal of the Additional Registrar, Cooperative Department, UT of Ladakh, for further deployment in the Sub-Ordinate Offices / Divisions of the Cooperative Department.
2. The appointee shall report to the Office of Additional Registrar, Cooperative Department, UT of Ladakh for joining within a period of one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards their pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with their respective place of posting upon their deployment in the Sub-ordinate Offices / Divisions of the Cooperative Department, UT of Ladakh.
