Whereas, Clause-10 of S.O. 65 dated 10.12.2021 of the Union Territory of Ladakh *Excise & State Taxes (Subordinate) Service Recruitment Rules, 2021* provides for maintenance and periodic updation of the seniority list of members of the service (other than district cadre) by the Administrative Department;

Whereas, after the final apportionment of employees between UT of Ladakh and UT of Jammu & Kashmir vide Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, all posts pertaining to the Excise & State Taxes Department stand classified as UT Cadre posts;

Whereas, the Combined Final Seniority List of Subordinate (Executive & Ministerial Staffs) of the Excise & State Taxes Department, UT Ladakh, was last notified vide Notification No.: 02 F of 2024, Dated: 08-01-2024;

2. Objections, if any, to the Tentative Seniority List shall be submitted within a period of 21 (twenty-one) days from the date of issuance of this notification.
3. No objection received after the stipulated period shall be entertained.

4. The Tentative Seniority List is purely provisional and is issued without prejudice to the outcome of any writ petition(s) or court case(s) pending, if any, before any competent Court of Law.


