1. The appointees shall be on probation for a period of two years with effect from the date of their joining the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of his performance or conduct, he is considered unsuitable for further retention in service, or
 - b) He is otherwise found ineligible or unsuitable to be retained in the service.
2. The above appointed have been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Legal (Subordinate) Service Recruitment Rules, 2021.
4. The appointees shall report to the **Secretary / Consultant, Department of Law & Justice, UT of Ladakh** for joining within a period of one (01) month, from the date of issuance of this Order, failing which his appointment shall be deemed to have been cancelled ab-initio.
