NOTIFICATION

Ladakh, the 19th of March, 2026

S.O. 164.— In exercise of the powers conferred by proviso to Article 309 of the Constitution of India read with S.O. 282(E) dated 21.01.2020, notified by the Ministry of Home Affairs, Government of India, the Lieutenant Governor of the Union Territory of Ladakh hereby makes the following rules to amend the qualifying service prescribed for promotion to the post of Senior Stenographer / Senior Scale Stenographer as existing and notified in the (Subordinate) Service Recruitment Rules of various Departments in the Administration of Union Territory of Ladakh, from time to time, namely:—

1. Short title, Commencement and Application: — (1) These rules may be called the *Union Territory of Ladakh (Reduction of Qualifying Service for Promotion to the post of Senior Stenographer / Senior Scale Stenographer) in (Subordinate) Service Recruitment Rules, 2026.*

(2) These rules shall come into force from the date of their publication in the Official Gazette.

(3) These rules shall apply to the method of recruitment and qualifying service prescribed for promotion to the post of Senior Stenographer / Senior Scale Stenographer, wherever such post exists in the (Subordinate) Service Recruitment Rules of various Departments in the Administration of Union Territory of Ladakh.

2. Amendment of qualifying service for promotion to the post of Senior Stenographer/Senior Scale Stenographer: —

In Schedule-II of the (Subordinate) Service Recruitment Rules of various Departments in the Administration of Union territory of Ladakh, wherever the post of Senior Stenographer / Senior Scale Stenographer exists, under the column relating to “Method of Recruitment” and “Qualifying Service for Promotion”, the existing entry: —

“100 % by promotion from Junior Stenographer / Junior Scale Stenographer with five (05) years’ substantive service as Junior Stenographer / Junior Scale Stenographer.” shall be substituted with the following, namely: —

“100 % by promotion from Junior Stenographer / Junior Scale Stenographer with Three (03) years’ substantive service as Junior Stenographer / Junior Scale Stenographer.”

3. Effect of these rules: —


Wherever the post of Senior Stenographer / Senior Scale Stenographer exists in the (Subordinate) Service Recruitment Rules of various Departments in the Administration of Union Territory of Ladakh, the qualifying service prescribed for promotion to the said post shall stand amended in terms of Rule 2 of these rules.
