Whereas, the Director, Rural Development Department, UT Ladakh, vide letter No. No.DRD/UTL/Estt/MF-Orderly/Offer/E-104/2026-1206, dated: 20.03.2026, intimated that the candidates mentioned at Annexure I has submitted undertakings expressing his unwillingness to accept the post.

Now therefore, in light of the above, the offer of appointment issued in favour of the candidate mentioned below for the post of Orderly/Chowkidar in Rural Development Department, UT Ladakh, is deemed to have been cancelled w.e.f. 20.03.2026.
