Whereas, pursuant to the recommendation of the LAHDC-KSSRB, (2) candidates were provisionally selected as Gram Sevika, in Rural Development Department of the Administration of Union territory of Ladakh, in Level-2 of pay matrix. (Rs.19,900-63,200).

Whereas, Rural Development Department UT Ladakh vide Memorandum No. No.M/1967/2023-RD&PR Section/771-776, dated: 18.02.2026, issued an offer of appointment to the candidates selected provisionally for the post of Gram Sevika with directions to submit the acceptance undertaking within 30 days from the issuance of the said memorandum.

Whereas, in terms of instructions contained at para (14) in the Memorandum issued by the office of the Administrative Secretary, Rural Development, UT Ladakh, the candidates who fail to submit the undertaking within a period of 30 days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment.

Whereas, the Director, Rural Development Department, UT Ladakh, vide letter NoDRD/UTL/VLW/MPW/LAHD-KSSRB/2025/E-161(A)/169-172, dated:24.02.2026, intimated that amongst (2) selected candidates, (1) candidate has submitted acceptance undertaking within stipulated time, Whereas (1) candidate mentioned at Annexure I has submitted undertakings expressing his unwillingness to accept the post.

Now therefore, in light of the above, the offer of appointment issued in favour of the (1) candidate mentioned below for the post of Gram Sevika in Rural Development Department, UT Ladakh, is deemed to have been cancelled w.e.f. 19.03.2026.

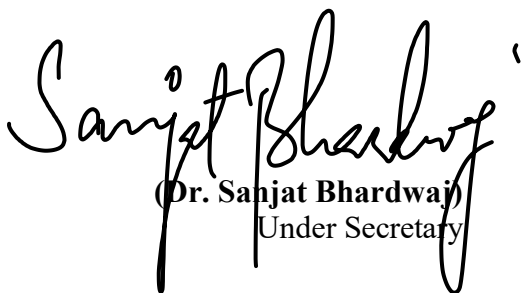
