Whereas, pursuant to the recommendations of the LAHDC-KSSRB, Kargil, eight (08) candidates were provisionally selected from the waiting list as **Junior Assistant**, in School Education Department, UT Ladakh in level-4 of pay matrix (₹25500-81100);

Whereas, the School Education Department UT Ladakh vide Memorandum No. **A/978/2023-EST SEC(GZ)-SED/1475-1483 dated: 27.02.2026** issued offer of appointment to the candidates selected provisionally for the posts of Junior Assistant with the directions to submit the acceptance undertaking within a period of thirty (30)days from the issuance of the said memorandum;

Whereas, in terms of instructions contained at para-15 of the Offer of appointment issued vide above Memorandum dated: 27.02.2026, the candidates who fail to submit the undertaking within a period of thirty (30) days from the date of issuance of memorandum shall result in the cancellation of the offer of appointment;

Whereas, the Chief Education Officer, Kargil has intimated that out of the eight (08) selected candidates who were issued Offers of appointment, only six (06) candidates have submitted the undertaking for acceptance of the Offer within the stipulated time i.e. by 26.03.2026 and the following two (02) candidates mentioned in the **Annexure I** to the Offer of appointment have not submitted undertakings of acceptance within the stipulated time period of thirty (30) days;

Now therefore, the offer of appointment issued in favour of the above two (02) candidates for the post of Junior Assistant in School Education Department, UT Ladakh, is deemed to have been cancelled w.e.f. 27.03.2026.
