As recommended by the Staff Selection Commission, and in pursuance of the Order dated 23.08.2025 of the Central Administrative Tribunal, Jammu Bench (Circuit Sitting at Leh), sanction is accorded to the appointment of following selected candidate as **Legal Assistant** (now redesignated as **Associate Law Officer**) in the Pay Level-6E (35900-113500), in the Department of Law and Justice, Union Territory of Ladakh;



The appointment shall be governed by the following terms and conditions: -

1. The appointee shall report in the Department of Law & Justice, UT of Ladakh within a period of 21 days from the date of issuance of this order and in case she fails to join within the stipulated time, she shall forego her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.
2. The appointment shall be in deference to the judgement of the Hon'ble CAT, Bench Jammu (Circuit Sitting at Leh) on dated 23.08.2025.
3. The appointment shall be effective from **the initial appointment date of her counterparts i.e. 12.09.2024** on **notional basis** for the purpose of seniority and other service benefits, without any claim to arrears of pay and allowances.
4. The service conditions of the above appointed Legal Assistant shall be governed by the Ladakh Legal (Subordinate) Service Recruitment Rules, 2021;


5. (i) If any adverse report about her character and antecedents is received from the Director General of Police, Criminal Investigation Department, Ladakh; or (ii) any qualification certificate /reserved category certificate/experience certificate (wherever applicable) is found false or fake on verification from the concerned issuing authorities, the appointed candidate shall have no right to claim her appointment and her appointment shall be deemed to have been cancelled ab-initio.
6. The salary of the appointee shall not be drawn and disbursed to her unless satisfactory report/genuineness of the certificates in respect of (i) and (ii) above is received.
7. The appointee shall be on probation for a period of two years and the conditions of probation as prescribed in the Union Territory of Ladakh Legal (Subordinate) Service Recruitment Rules, 2021 and other rules and instructions issued in this regard by the Central Government/Administration of Union Territory of Ladakh shall be applicable.
8. The appointed candidate shall have to serve anywhere within the territorial/Administrative jurisdiction of Union Territory of Ladakh
9. The appointment of the above appointee shall be subject to outcome of the writ petition(s)/OA, if any, pending on the subject before any Competent Court of law.
