**Whereas**, as per the Jammu and Kashmir Reorganization Act 2019, the Union territory of Ladakh has been established.

**Whereas**, in reference to the Jammu and Kashmir Reorganization Act 2019, the Union territory of Jammu and Kashmir has issued an apportionment order in favour of the Officers/Officials who have opted for UT-Ladakh vide Government order No: 1212-JK(GAD) of 2021, 505-JK(GAD) of 2022, 1245-JK(GAD) of 2022, and 486-JK(GAD) of 2023, dated 15.11.2021, 05.05.2022, 17.10.2022, and 17.04.2023, respectively.

**Whereas**, as per the directions from this directorate, the Chief Medical Officers/Deputy Chief Medical Officer, Leh and Kargil have submitted the service biodata of all the Union territory cadres, Divisional cadres, and their feeding cadres for the formulation of their cadre wise seniority list.

**Whereas**, while formulating the same, this Directorate could not find the apportionment order number and serial numbers in the apportionment orders of the many Officers/Officials and accordingly submitted the same by the Chief Medical Officers.

**Whereas**, on the basis of the above, the 1st tentative seniority list of Jr. Theatre Assistant/Lady Theatre Assistant was issued.

**Whereas**, in response thereto, the Chief Medical Officers, Leh and Kargil, submitted the raised objections vide letter Nos. E-15267 M/1409/2023-CMO SEC (Leh) 10167 and CMO-K/Seniority List/Div./2023/6780-81 dated 10.08.2023 and 06.10.2023, respectively.

**Whereas**, while examining the same, it was observed that separate selection lists were issued by the recruiting agency, i.e., the SSRB. The SSRB clarified that selections were made in order of merit, however, due to separate lists for the two designations, inter-se seniority between candidates of different categories could not be directly determined from the merit position.

**Whereas,** in the absence of a unified merit list, the seniority has been determined based on date of birth, i.e., Mr. Mohammad, Theatre Assistant (DOB: 28.03.1972), and Smt. Sekina Banoo, Lady Theatre Assistant (DOB: 26.04.1982); accordingly, Mr. Mohammad is placed senior to Smt. Sekina Banoo.

**Whereas,** vide letter dated 25.03.2026, the Chief Medical Officer, Kargil, submitted another representation of Sh. Altaf Hussain, Theatre Assistant, seniority Serial No. 18, wherein it was stated that he is senior to Sh. Mohd Hashim, placed at seniority list Serial No. 09.

**Whereas,** while examining the same, it was observed from the SSRB, Kargil selection list that Sh. Altaf Hussain, at Serial No. 06, secured 44.42 points, whereas Sh. Mohd Hashim, at Serial No. 07, secured 43.72 points.

**Whereas,** based on the above, the seniority of Sh. Altaf Hussain, previously at Serial No. 18, has been revised and fixed at Serial No. 09, above Sh. Mohd Hashim.

**Whereas,** in response to Chief Medical Officer, Leh's letter No. E-15267 M/1409/2023-CMO SEC (Leh) 10167 dated 10.08.2023, the case of Smt. Tsering Landol, seniority list serial No. 17, was also examined, and as per the merit-wise selection list issued by SSRB, Leh vide No. DDE&CCL/DRB/Jr. Theatre Tech/11/778-90 dated 19.07.2011, Smt. Tsering Landol is placed above Smt. Chamba Lamo, presently at seniority Serial No. 15, having secured 58.33 and 56.45 points, respectively.

**Now, therefore,** the 2nd tentative Seniority list of Theatre Assistant/ Lady Theatre Assistant L-4 of the Health and Medical Education Department Union territory of Ladakh as Annexure "A" to this order has been prepared and is issued for information to all the concerned. Any individual who is aggrieved with the positions assigned to him/her may file their objections if any, under the relevant provisions of CCA, within 15 days in the office of Chief Medical Officer, Leh / Kargil.

**Note:** The date of birth recorded against the names in the seniority list shall not be considered as authentic and shall be subject to verification of service records."
