Whereas, as per SRO 698, dated 25.10.2019 , 1211-JK(GAD) of 2021, dated: 15.11.2021, 449-LA (GAD) of 2023, dated: 11.12.2023 and Extension of SNM, Hospital, from 200-350 bedded vide MoHFW, Gol, letter No: Z.16017/15/2023-H II (FTS No. 8257095), dated: 06.12.2024, a total of 2722 Non-Gazetted posts of various have been allocated to the Health and Medical Education Department Union Territory of Ladakh.

Whereas, in reference to the Jammu and Kashmir Reorganization Act 2019, the Union Territory of Jammu and Kashmir has issued an apportionment order in favour of the Officers/Officials who have opted for UT-Ladakh vide Government order No: 1212-JK(GAD) of 2021, 505- JK(GAD) of 2022, 1245-JK(GAD) of 2022, and 486-JK(GAD) of 2023, 117-JK (GAD) of 2024 and 1794-JK(GAD) of 2024, dated 15.11.2021, 05.05.2022, 17.10.2022, 17.04.2023, 07.06.2024 and 18.10.2024 respectively.

Whereas, as per the directions from this directorate, the Chief Medical Officers Deputy Chief Medical Officer, Leh and Kargil have submitted the service biodata of all the Union territory cadres, Divisional cadres, and their feeding cadres for the formulation of their cadre wise seniority list.

Whereas, in response to the above, this Directorate sought a para-wise reply from the Chief Medical Officer, Kargil, vide letter No. 24993A/1406/2024-EST SEC (DHS) 6260 dated 06.01.2025 and reminder vide letter No. 36970A/2232/2025-EST SEC (DHS) 11764-66 dated 06.01.2026.

Whereas, the Chief Medical Officer, Kargil, vide letter No. CMO-K/SL-HE/2025/7708-09 dated 07.01.2026, submitted the reply and clarified that the seniority position of Sh. Hassan Khan was examined with reference to the available service records and relevant rules. It was further reported that the objection raised by the official was found to be baseless.

Whereas, on the basis of which, the 2nd tentative seniority list has been issued vide this Directorate order No: 254-DHSL of 2026, dated: 10.03.2026, with the direction to submit the objection if any from the concerned.
