Leh, the 27<sup>th</sup> of April, 2026

**S.O. 180 .** - In exercise of the powers conferred by section 5 of the Jammu and Kashmir Land Revenue Act, 1996 (*Act No. XII of Samvat 1996*), in its application to the Union territory of Ladakh; the Administration of the Union territory of Ladakh hereby creates the following new Districts, in the Union territory of Ladakh, as under: —

- (i) Sham, (Headquarter: Khaltse)
- (ii) Nubra, (Headquarter: Diskit)
- (iii) Changthang, (Headquarter: Nyoma)
- (iv) Zaskar, (Headquarter: Padum) and
- (v) Drass, (Headquarter: Drass-Ranbirpura).

2. Consequent upon the above creation, the Administration of the Union territory of Ladakh hereby redefines the territorial limits of the existing and newly created Districts as detailed herein after, as follows: —
