- (ii) The information regarding qualification/date of appointment as given in the relevant column in the tentative seniority list if found incorrect, the testimonials in original shall be furnished for necessary rectification.*
- (iii) That the tentative seniority list is issued without prejudice to the outcome of writ petition(s), if any, pending in any Court of Law.*
- (iv) Objection to this tentative seniority list amongst the members of the service, if any, shall have to be submitted within Seven (07) days from the*

date of issuance of this order with documentary proof and no objection shall be considered/entertained thereafter.

(v) In case no objection is received within the stipulated time, it shall be presumed that nobody has any objections to the position assigned and shown in the tentative seniority list and a final seniority list shall accordingly be notified after the expiry of stipulated period.


