

The Ladakh Subordinate Services Staff Selection Board vide its Advertisement No. LSSSSB/2025/01 had advertised 12 vacancies (ST-8, ALC-1, EWS-3 including PwBD-2), for the post of Legal Assistant (Post Code: LSB2502) and 08 vacancies (ST-8), for the post of Junior Legal Assistant (Post Code: LSB2504).
