Whereas, as per the Jammu and Kashmir Reorganization Act 2019, the Union Territory of Ladakh has been established.

Whereas, as per SRO 698, dated 25.10.2019 , 1211-JK(GAD) of 2021, dated: 15.11.2021, 449-LA (GAD) of 2023, dated: 11.12.2023 and Extension of SNM, Hospital, from 200-350 bedded vide MoHFW, GoI, letter No: Z.16017/15/2023-H II (FTS No. 8257095), dated: 06.12.2024, a total of 2722 Non-Gazetted posts of various have been allocated to the Health and Medical Education Department Union Territory of Ladakh.

Whereas, in reference to the Jammu and Kashmir Reorganization Act 2019, the Union Territory of Jammu and Kashmir has issued an apportionment order in favour of the Officers/Officials who have opted for UT-Ladakh vide Government order No: 1212-JK(GAD) of 2021, 505-JK(GAD) of 2022, 1245-JK(GAD) of 2022, and 486-JK(GAD) of 2023, 117-JK(GAD) of 2024 and 1794-JK(GAD) of 2024, dated 15.11.2021, 05.05.2022, 17.10.2022, 17.04.2023, 07.06.2024 and 18.10.2024 respectively.

whereas, as per the directions from this directorate, the Chief Medical Officers /Deputy Chief Medical Officers, Leh and Kargil have submitted the service biodata of all the Union Territory cadres, Divisional cadres and their feeding cadres for the formulation of their cadres wise seniority list.

whereas, 2nd Tentative Seniority list of Junior Theatre Assistant /Lady Theatre Assistant was circulated vide this directorate order No: 306/DHS/2026 dated: 10.04.2026 for seeking comments/objections if any from the concerned.

Whereas, in response to that, the Chief Medical Officer, Kargil submitted objections vide Letter Nos. CMO-K/Seniority list/2026/591 dated 22.04.2026, CMO-K/ Seniority list/2026/570-71 dated 21.04.2026, CMO-K/Seniority-list/ 2026 /468-69 dated 18.04.2026, CMO-K/Seniority-list/2026/659-61 dated 24.04.2026 and CMO-K/Corsp-DHS/2026/632-34 dated 23.04.2026 regarding the 2nd Tentative Seniority List.


Whereas, the Chief Medical Officer, Kargil has also forwarded a joint application along with affidavits submitted by the Junior Theatre Assistants/Lady Theatre Assistants stating that they have no objection to the 2nd Tentative Seniority List of Theatre Assistant/Lady Theatre Assistant of UT Ladakh and have withdrawn all previous objections.

Whereas, the Chief Medical Officer, Leh submitted a Nil comments/objections report vide Letter No. CMO/Gaz/798 dated 22.04.2026.

Now, therefore, the 3rd tentative seniority list of Junior Theatre Assistant/ Lady Theatre Assistant of the Health and Medical Education Department, UT-Ladakh as Annexure "A" to this order has been prepared and issued for information to all the concerned. Any individual who is aggrieved with the positions assigned to him/her may file their objection if any, under the relevant provision of CCA **within 07 days** in the office of Chief Medical Officer, Leh/Kargil.

Note: the date of birth recorded against the names in the seniority list shall not be considered as authentic and shall be subject to verification of service records.


