Ladakh, the 5th of May, 2026.

S.O. 184 In exercise of the powers conferred by S.O 282(E) dated 21.01.2020, the Lieutenant Governor of the Union Territory of Ladakh, hereby makes the following amendments in the Ladakh Social and Tribal Welfare (Subordinate) Services Recruitment Rules, 2021 notified vide S.O.76 dated 28.12.2021 and as amended vide S.O. 115 dated 27.10.2022 and S.O. 124 dated 04.11.2024, in Schedule-II (B).

- Short title and commencement** – (1) These rules may be called the Union Territory of Ladakh Social & Tribal Welfare (Subordinate) Services Recruitment (Amendment) Rules, 2026.
(2) These rules shall come into force from the date of their publication in the Official Gazette.
- Amendment to Schedule- II (B)- The “Schedule- II (B)” to the said Rules shall be substituted by the following Schedule, as follows, namely: -

Level 4 (25500-81100)	Supervisor	Female Candidates with Bachelors / Masters in Social Work / Social Sciences from a recognized University	i. 50% by direct recruitment. ii. 25% by selection through Departmental Selection Committee from amongst Graduate Anganwadi Workers having rendered 5 years' service. iii. 25% by selection through Departmental Selection committee from amongst the Matriculate Anganwadi Workers with 10 years' service.
