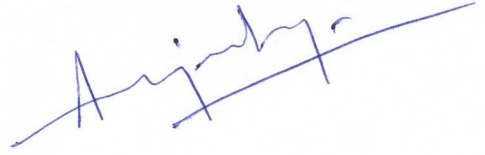
4. Only those comments, suggestions, or objections received within the stipulated period shall be considered in accordance with the applicable rules and instructions.
