- Consider and recommend projects to the National Level Steering Committee (NLSC), including those involving private sector, after due assessment of compliance with the prescribed eligibility conditions, conditions precedent, and evaluation criteria under the Scheme;
- Identify and facilitate development and funding of external infrastructure, including through convergence and prioritisation of resources under ongoing Central and

- State Government schemes and ensure inter-departmental coordination for timely implementation of such infrastructure;
- iii. Review implementation progress, milestone achievement, and utilisation of fund for the approved projects, and provide necessary directions for timely completion; and
- iv. Facilitate integration of state-specific policies and incentives for attracting investors and ensure efficient utilisation of the infrastructure created under the Scheme.
