- The appointees shall be on probation for a period of two years with effect from the date she joins the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - On the basis of her performance or conduct, she is considered unsuitable for further retention in service, or
 - She is otherwise found ineligible or unsuitable to be retained in the service.

2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Handicraft (Subordinate) Service Recruitment Rules, 2022.
4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.
