In exercise of the powers conferred under Section 2(1)(u) of the Bharatiya Nagarik Suraksha Sanhita, 2023, and in view of the increasing incidence of cyber-enabled offences in the Union territory of Ladakh, the Lieutenant Governor, Union territory of Ladakh, is pleased to order as follows:

1. The existing Cyber Unit, Leh is hereby notified as the "Cyber Police Station, Ladakh", with jurisdiction extending over the entire Union territory of Ladakh.
2. The Cyber Police Station, Ladakh shall function as the centralized Cyber Police Station of the UT and shall be responsible for registration and investigation of cybercrime cases and related offences under the Information Technology Act, 2000, the Bharatiya Nyaya Sanhita, 2023 and other applicable laws.
3. The Cyber Police Station shall facilitate e-Zero FIRs, coordination with the National Cyber Crime Reporting Portal (NCRP) and 1930 helpline, preservation and collection of digital evidence, prompt action for freezing/holding of fraudulent financial transactions, and coordination with I4C, banks, financial institutions, telecom service providers and other concerned agencies.
4. The Cyber Police Station, Ladakh shall function under the administrative and operational control of the Chief Executive Officer (CEO) of UT Ladakh Cyber Crime Coordination Centre (L4C), who shall make necessary arrangements for its effective functioning, including coordination with concerned agencies, from the existing resources of Ladakh Police, as an interim arrangement.
5. Any existing administrative arrangement inconsistent with this Order, to the extent of such inconsistency, shall stand modified accordingly. Nothing contained here in shall affect any investigation, proceeding or action already undertaken by any competent police unit, which shall continue in accordance with law.
6. This order shall come into force with immediate effect.
